# **Buildings & Grounds Committee:**

Rachael Morrow reported for the Special Meeting that met on August 3, 2023. To select a CMR. Branco, Nabholz, and Crossland presented. Branco was selected as the CMR for the TLC expansion project.

#### **Executive Committee:**

Rachael Morrow reported for the Executive Committee that met on August 9, 2023. The meeting consisted of previewing the August agenda and ARPA updates.

## **Directors Financial Update:**

Regina Cooper presented a financial update.

### As of July 31, 2023

- 8.3% of the year has elapsed
- 5.4% of the budget has been spent
- 2.9% under budget for expenditures

#### Revenues

- Taxes received in July were \$64,491.18. These collections were delinquent taxes and penalty & interest on taxes.
- Revenue other than taxes in July was \$153,333.97, 8.5% of the amount budgeted.
- Total revenues for July were \$218,025.15.
- Fines for July were \$9,328.07, 7.7% of the budget.
- Interest income in July was \$58,971.60 or 31.3% of the budgeted amount.
- Out-of-County fees for July were \$5,520.00 at 9.8% of the budget.
- Passport fees in July were \$21,465.00 or 9.1% of the budget.

#### Expenses

- Salaries for July were \$584,859.44 with a headcount of 229/226.
- Health insurance premiums included the first two payments for the fiscal year.
- Total personnel expenses for July were \$778,972.33, 7.5% of the budget.
- Insurance for July was \$29,163.50, 20.1% of the budget, a timing issue.
- Building rentals were a timing issue with \$24,494.02 spent in July, 16.7% of the budget.
- Utilities in July were \$22,465.92 at 7.1% of the budgeted amount.
- Total operating expenses for July were \$987,862.21, 5.6% of the budget.

Operating cash at the end of July was \$8,974,473.80.
