Selecting Proposals:

1. Bids will be evaluated using the following criteria:
 - Price of the eligible products and services - 30%
 - Prior experience with vendor - 20%
 - Management Capability - 10%
 - Uniformity with existing network - 20%
 - Service and support - 20%
2. Alternatives, variations and exceptions must be clearly stated.
3. All bids must be itemized and include per unit and total cost of items.
4. Vendors must be a participant in the Federal E-Rate Program and supply a valid SPIN number for their bid to be considered.
5. E-Rate Funding: NOTE: In the event E-Rate funding is not approved by the SLD, any/all contracts or agreements shall be null and void. All services are contingent upon successful E-Rate funding and proposals come in within our budget allocated by E-Rate program. In the event the proposals are over our E-Rate budget, items will be removed to get our contracted services within our budget.

Please bid on the following. Indicate items that do not qualify or partially qualify for E-Rate funds and indicate this on your response. Prices should include all applicable taxes and shipping costs.

All products and services are to be delivered between July 1, 2020 and September 30, 2020. Please specify the expected delivery date in your response.
